**H.E. Mr. Nassir Abdulaziz Al-Nasser**  
**High Representative, United Nations Alliance of Civilizations**  
**@UNAOC**

Mr. Nassir Abdulaziz Al-Nasser assumed the leadership of the Alliance in March 2013. As a veteran diplomat and the 66th President of the United Nations General Assembly, he has devoted his time and work to peace building and promoting the culture of peace, tolerance and reconciliation. Mr. Al- Nasser, who is now ranked as a Minister at the Ministry of Foreign Affairs in Qatar, has served as his country's Permanent Representative to the United Nations, from 1998 to 2011. The highlight of his career was when he was elected as the President of the Sixty-Sixth session of the United Nations General Assembly from September 2011 to 2012. In December 2006, he was President of the UN Security Council, representing the State of Qatar in the Council during the two-year period when Qatar was a non-permanent member. During this time, the Council took action on several issues, including international cooperation to combat terrorism and the protection of journalists in armed conflict. As a veteran diplomat, he played several leading roles including President of the High-level Committee on South-South Cooperation. As chair of the Group of 77 and China, he guided action that led to the establishment of the South Fund for Development and Humanitarian Affairs, a financing mechanism that helps countries of the South address issues such as poverty, hunger and natural disasters. Mr. Al-Nasser is the recipient of numerous awards and honorary doctorates from various governments.



**Dr. Moustafa Bayoumi @BayoumiMoustafa**  
**Professor of English, Brooklyn College**

Moustafa Bayoumi is the author of the critically acclaimed “How Does It Feel To Be a Problem?: Being Young and Arab in America” (Penguin), which won an American Book Award and the Arab American Book Award for Non-Fiction. The book has also been translated into Arabic by Arab Scientific Publishers and it has been chosen as the common reading for incoming freshmen at universities across the country. His next book, “This Muslim American Life: Dispatches from the War on Terror, was recently published by NYU Press. His writing has appeared in *The New York Times Magazine*, *New York Magazine*, *The Guardian*, *The National*, CNN.com, *The London Review of Books*, *The Nation*, *The Chronicle of Higher Education*, *The Progressive*, and many others. His essay “Disco Inferno” was included in the collection Best Music Writing of 2006 (Da Capo). Bayoumi is also the co-editor of *The Edward Said Reader* (Vintage) and editor of *Midnight on the Mavi Marmara: the Attack on the Gaza Freedom Flotilla and How It Changed the Course of the Israel/Palestine Conflict* (O/R Books & Haymarket Books). With Lizzy Ratner, he also co-edited a special issue of *The Nation* magazine on Islamophobia (July

2-9, 2012). He has been featured in *The Wall Street Journal*, *The Chicago Sun-Times*, and on CNN, FOX News, Book TV, National Public Radio, and many other media outlets from around the world.



**Dr. Agnès Callamard @AgnesCallamard**  
**Director, Global Freedom of Expression & Information; Special Adviser to the President, Columbia University @globalFoEandI**

Dr. Agnès Callamard is the Director of Columbia University Global Freedom of Expression & Information, an initiative seeking to advance understanding on freedom of expression global norms. She spent nine years as the Executive Director of ARTICLE 19, the international human rights organization promoting and defending freedom of expression and access to information globally. She founded and led HAP International (the Humanitarian Accountability Partnership), which is the first self-regulatory body for humanitarian agencies at the international level. Prior to this, Dr. Callamard was Chef de Cabinet for the Secretary General of Amnesty International (AI) and AI's Research-Policy Coordinator, leading AI's policy work and research on women's human rights. She has advised senior levels of multilateral organizations and governments around the world and has led human rights investigations in more than 30 countries. She has published broadly in the field of human rights, women's rights, refugee movements and accountability and holds a PhD in Political Science from the New School for Social Research in New York.



**Ashraf El Nour**  
**Permanent Observer for the International Organization for Migration to the United Nations @IOMatUN**

Mr. El Nour began his career in 1988 at CARE International, serving as an Assistant Programme Coordinator for the next three years. In 1991, he went on to join IOM, first as Coordinator for Northern Iraq until 1993 and then as their Coordinator of Operations in Mozambique until 1995. Moving to the agency's headquarters in Geneva, he worked as Programmes Coordinator for Migration for Development and Technical Cooperation until 1998, when he became Regional Adviser for Africa and the Middle East until 2001. After working as Senior Recovery Adviser at the United Nations Development Programme's (UNDP) Geneva-based Bureau for Crisis Prevention and Recovery, Mr. El Nour returned to IOM as Special Assistant with the Office of the Director General from 2006 to 2007. He then served in Kenya as Regional Representative for East and Central Africa, from 2007 to 2012, and as Regional Director for East and Horn of Africa from 2013 until his current appointment. Born in Khartoum in 1963, Mr. El Nour holds a master's degree in political science from Aligarh Muslim University in India.

Before joining the UN, Ms. Gallach served as Head of the Public Relations Unit in the Council of the European Union, Directorate General for Information and Communication, Brussels. In that role she was responsible for designing and implementing the EU Council's communication strategies and for its public relations and outreach to key partners, including opinion-makers, civil society and academia. Prior to that, Ms. Gallach was Spokesperson of the Spanish Government for the European Union rotating Presidency (2010); Spokesperson and Chief Media Advisor of the European Union High Representative for the Common Foreign and Security Policy (1999-2009); and Deputy Spokesperson of the North Atlantic Treaty Organization (NATO) and Chief Media Advisor for the Secretary-General (1996-1999). Ms. Gallach spent more than 15 years as a journalist, during which time she held the positions of senior correspondent for EFE, the Spanish news agency, in Brussels (1993-1996) and in Moscow (1990-1992). She was also a correspondent with El Periodico newspaper in Barcelona (1986-1990), a United States correspondent for Avui newspaper (1984-1986) and a reporter with TVE Barcelona (1983-1984).

Before joining Bloomberg Television, David Gura was a senior reporter for, and the principal back-up host of, Marketplace, the public radio business and economics program. He has traveled widely, reporting on the U.S. economy. Much of his recent coverage has centered on the recession and recovery, and the implementation of healthcare and financial reform. He has reported on countless budget battles, showdowns and shutdowns. Ahead of the 2014 election, he focused on campaign finance. After the shooting at Sandy Hook Elementary School, in Newtown, Conn., he spent several months reporting a series called "Guns and Dollars," about the U.S. firearms industry. He began his career at NPR, first as an editor and a producer, then as a reporter for The Two-Way, the network's breaking news blog. He regularly contributed radio pieces to NPR's flagship news magazines, All Things Considered, Morning Edition, and Weekend Edition. His writing has appeared in *The New York Times*, the *Los Angeles Times*, the *Columbia Journalism Review*, and the *Virginia Quarterly Review*.

She writes about the *banlieues*, discrimination, education, and racism. She also spent some time in Tunisia during the revolution, and in Gaza in 2014 to report for the Bondy Blog.

Jean-Paul Laborde of France was appointed Executive Director of CTED and Assistant Secretary-General in June 2013. Mr. Laborde served for 22 years in the French criminal justice system and Government as Judge, Assistant Prosecutor-General, Chief Prosecutor, and Head of the National Service for the Inspection of Penitentiary Services. From December 2010 until his appointment at CTED, Mr. Laborde served as a judge in the Criminal Chamber of France's Supreme Judicial Court (Cour de Cassation). Mr. Laborde had previously served with the United Nations for 18 years, holding senior positions in counter-terrorism and criminal justice with the United Nations Office on Drugs and Crime in Vienna (1993-2008), the Department of Political Affairs, and the Counter-Terrorism Implementation Task Force (2009-2010). Author of a scholarly book and numerous articles, Mr. Laborde has written extensively on issues such as international criminal law, terrorism and the United Nations. He has also lectured at universities in France and the United States.

Michelle Mittelstadt is responsible for developing and implementing the Migration Policy Institute (MPI)'s strategic communications, coordinating public and media outreach and events, managing the editing and publishing process, and overseeing the Institute's websites, social media platforms, and publication of its online journal, the Migration Information Source. A veteran journalist, she joined MPI after covering immigration policy, Congress, and border-related issues in the Washington bureaus of The Associated Press, *The Dallas Morning News*, and the *Houston Chronicle*. She has written hundreds of articles examining U.S. immigration policy, border and interior enforcement, and the post-9/11 legislative and executive branch changes that have altered the immigration landscape. She also covered the Departments of Justice and Homeland Security. Prior to coming to Washington, Ms. Mittelstadt was an editor with The Associated Press in Dallas and managing editor of *The Courier Herald* in Dublin, Ga.



**Eric Newton @EricNewton1**  
**Innovation Chief, Professor of Practice, The Walter Cronkite School of Journalism and Mass Communication**

As the Walter Cronkite School of Journalism and Mass Communication, Eric Newton drives change and experimentation at Cronkite News, the news division for Arizona PBS. He also serves Knight Foundation as a consultant, working on special projects and endowment grants. In his nearly 15 years at the John S. and James L. Knight Foundation, he expanded the foundation's journalism and media innovation program, overseeing the development of more than \$300 million in grants, \$160 million of which went to universities for pioneering projects in journalism education. Newton developed grants for groundbreaking initiatives such as Poynter Institute's News University, the largest online journalism-training portal in the world, and Sunshine Week, an annual national observance of the importance of open government. His work was central to the creation of the Carnegie-Knight Initiative on the Future of Journalism Education, a high-visibility consortium of leading journalism schools dedicated to transforming journalism education at the university level. At Knight Foundation in 2007, Newton's team launched the nationally recognized Knight News

Challenge, a media innovation competition that funds breakthrough ideas in journalism. Before joining Knight Foundation, Newton was founding managing editor of the Newseum in Arlington, Va. (now in Washington, D.C.). As managing editor of the *Oakland Tribune*, he helped guide the paper to numerous awards, including a Pulitzer Prize. He is the author of books and publications, including “Searchlights and Sunglasses: Field Notes From the Digital Age of Journalism.” He shared a Peabody Award for Link TV’s nightly news program, “Mosaic: World News From the Middle East.”



**Dr. Andre Oboler (Australia) @oboler**  
**CEO, Online Hate Prevention Institute @OnlineHate**

Dr. Andre Oboler is CEO of the Online Hate Prevention Institute (OHPI), an Australian charity combating all forms of online hate. He serves as Co-Chair of the Working Group on anti-Semitism in the Media and on the Internet of the Global Forum to Combat anti-Semitism, an expert member of the International Holocaust Remembrance Alliance, and a Distinguished Visitor for the IEEE Computer Society. He has served as an expert member of the Inter-Parliamentary Coalition to Combat Anti-Semitism, has testified before the Italian Parliament, and is featured regularly in the media. Dr. Oboler founded the Online Hate Prevention Institute in 2012 in order to take the lessons learned at the leading edge of combating online anti-Semitism and to apply them for the benefit of all sections of society. OHPI has produced world-leading work tackling online issues of anti-Semitism, anti-Muslim hate, racism against Indigenous Australians, misogyny, homophobia and more. OHPI’s flagship project, FightAgainstHate.com, is a unique online reporting system that provides data on online hate and transparency on the effectiveness of social media companies in responding to it. Led by Dr. Oboler, OHPI provides monitoring of online hate, technical recommendations to improving social media platforms, policy recommendations and law reform recommendations. Dr. Oboler holds a PhD in Computer Science from Lancaster University (UK) and a Juris Doctor from Monash University (Australia).

Mirta Ojito was born in Havana, Cuba, and came to the United States in 1980 in the Mariel boatlift. She has received the American Society of Newspaper Editors’ Award for best foreign reporting, and she shared the 2000 Pulitzer Prize for national reporting, for her contribution to the series “How Race Is Lived in America.” Her work has appeared in several anthologies, including *Written into History: Pulitzer Prize Reporting of the Twentieth Century* from The New York Times, edited by Anthony Lewis. Ojito has taught journalism at New York University, Columbia University, and the University of Miami. She writes for *The New York Times* from Miami.

Michael Oreskes is Senior Vice President for News, and Editorial Director at National Public Radio (NPR). Prior to that, he was Vice President and Senior Managing Editor at the Associated Press. There, he supervised the daily all-format and global report. He came to the Associate Press from the *International Herald Tribune* in Paris, France where he was Executive Editor. He spent 27 years with The New York Times Co. He began in 1981 as reporter, covering local, state and national politics; he was later appointed Metro editor, Washington bureau chief and deputy managing editor. Before coming to The *Times*, he worked for the *New York Daily News*, where he was a general assignment reporter, City Hall bureau chief, and also covered education, Albany and the labor beat. He is the co-author of *The Genius of America: How The Constitution Saved our Country and Why it Can Again* (Bloomsbury).

She spent 15 years at *BusinessWeek* magazine, where she was senior editor for news, Washington bureau chief, and a national correspondent. She was also editor-in-chief of the politics and opinion channels of Yahoo News, the largest digital news site in the United States. Earlier in her career, she worked for nine years in Europe, writing for *Newsweek*, the *Christian Science Monitor*, the *International Herald Tribune* and others before joining London-based *International Management* magazine as Paris bureau chief. More recently, she has written for *The New York Times*, The Economist Group, and others, in addition



Rosario joined UNESCO's Division of Freedom of Expression and Media Development in 2009, and has since been involved in projects promoting freedom of expression, freedom of information and media development in different regions. These have included initiatives focused on ethical and professional standards in journalism, safety of journalists, Internet privacy and freedom of expression, among others. She is currently in charge of coordinating the media axis of the NET-MED Youth project, funded by the European Union and implemented by UNESCO in Southern Mediterranean countries. In this framework, she has managed dialogue, capacity-building and media production efforts that promote youth's self-expression, their role in intercultural dialogue and peace-building; aiming, among other objectives, to counter hate-speech. Prior to joining UNESCO, Rosario worked for the World Bank, in the fields of access to information and citizen participation. She also conducted research for the Office of the Special Rapporteur for Freedom of Expression within the Inter-American Commission on Human Rights, and for the Center for Studies on Freedom of Expression and Access to Information (CELE, Palermo University's School of Law, Buenos Aires). She holds an MPhil in Development Studies from Oxford University, where she also worked for the Reuters Institute for the Study of Journalism; and an undergraduate degree in Political Science/International Relations from the Argentine Catholic University (Buenos Aires).

Under Yearwood's leadership, the World Desk of *The Miami Herald* has won numerous awards, including the Arthur Ross Award for best coverage of Latin America and it was named a finalist for the Pulitzer Prize in Breaking News for the Haiti earthquake coverage. It has also won recognition from Columbia University, the Overseas Press Club, the American Academy of Diplomacy and the King of Spain. Yearwood's legacy at the *Herald* includes conceiving and directing the landmark "A Rising Voice" series that reported on the empowerment and civil rights struggle occurring among Afro-Latin Americans. Yearwood is a regular guest on National Public Radio, and local and national television programs, including the Tavis Smiley Show. During the course of his career, he has met with countless world leaders ranging from Nelson Mandela and Margaret Thatcher to President Obama and Jordan's King Abdullah. Prior to joining the *Miami Herald*, Yearwood was National/International Editor at the *Fort Worth Star-Telegram* in Texas. Before that, he spent two years in Trinidad as founding publisher/editor of IBIS, a general lifestyle magazine. He also spent 10 years at *The Dallas Morning News*, where he reported from Europe, Africa, Asia and the Caribbean.
