The High Representative for UNAOC convened the first meeting of the High-Level Advisory Council of the High Representative of UNAOC with the participation of prestigious members including: H.E. The discussion focused on the theme: "Time to Heal: The Global Context – How can UNAOC best support the UN efforts and relevant stakeholders to heal, recover and rebuild resilient, cohesive and peaceful societies in line with its mandate?".

HIGHLIGHTS

The United Nations Alliance of Civilizations (UNAOC) and Fundación Mujeres Por Africa organized an interactive webinar on "Women and Mediation in Intercultural and Interreligious Conflicts" as part of their joint initiative, Women's Alliance for Peace, to support the role of women as peace mediators and negotiators in conflicts with a sociocultural and religious dimension.

Fifteen women mediators from Mali and the Central African Republic participated in the discussion. They explored the socio-cultural challenges in the multidimensional crises in both countries, the role of religious and traditional leaders in this context, and tools to help participants be better equipped in their work. On the margins of the 2021 High-Level Political Forum, UNAOC, the UN Office on Genocide Prevention and the Responsibility to Protect (OSAPG), and the Office of the High Commissioner for Human Rights (OHCHR) organized a side event on the implementation of the "Global Pledge for Action by Religious Actors and Faith-Based Organizations to Address the COVID-19 Pandemic in Collaboration with the United Nations" with the co-sponsorship of the Permanent Missions of the Kingdom of Morocco and the Republic of Croatia to the UN, and Religions for Peace.

The Global Pledge for Action is the result of a consultation that UNAOC, OSAPG, and OHCHR co-organized with a group of religious leaders and actors and faith-based organizations in 2020 to explore innovative ways to partner in response to COVID-19. One year after the launch of the Global Pledge for Action, and after six webinars co-organized by the three UN partners on its implementation, this side event helped take stock of and advocate for further implementation of the Global Pledge for Action.

In his opening remarks, the High Representative for UNAOC, Mr. Moratinos, emphasized the crucial role of religious actors and faith-based organizations: "The issues identified in the Global Pledge continue to play a central role in the multifaceted response that is needed to come out of the pandemic stronger and united. UNAOC is committed to assisting in the implementation of the Global Pledge by continuing to strengthen our partnership with all relevant actors, prioritizing recommendations coming out of the webinars and identifying opportunities to test them." The High-Representative for UNAOC, Mr. Moratinos, met with Mr. Mark Weitzman, Director of Government Affairs for the Jewish global human rights organization Simon Wiesenthal Center. They spoke about their respective work and good practices for combating antisemitism. (8 July)



Mr. Moratinos met with the Permanent Representative of the Slovak Republic to the United Nations, H.E. Mr. Michal Mlynár. They exchanged views on promoting freedom of religion and belief and discussed the UN Plan of Action to Safeguard Religious Sites. (13 July)



Mr. Moratinos met with the Permanent Representative of the Sultanate of Oman to the United Nations, H.E. Ambassador Dr. Mohamed Al-Hassan, to discuss enhancing cooperation with UNAOC, especially in promoting interreligious and intercultural dialogue and building cohesive pluralistic societies. Ambassador Al-Hassan reiterated his support for the work and objectives of UNAOC. (10 July)

53 outstanding youth from Afghanistan, Bangladesh, India, Myanmar, Pakistan, and Sri Lanka were selected to participate in the Digital Games for Peace project of UNAOC, UNESCO MGIEP and the UN Office of Counter-Terrorism (UNOCT).

They participated in their first training session with Ms. Susanna Pollack, President of Games for Change, who shared key lessons on the potential and impact of games in promoting social change (16 July).

In the next few weeks, they will receive additional capacity-building training with world-class experts on digital games, social-emotional learning, intercultural dialogue, and prevention of violent extremism.



Within the framework of their joint #YouthWaging-Peace programme, UNAOC and the UNESCO Mahatma Gandhi Institute of Education for Peace and Sustainable Development (MGIEP), together with the UNESCO New Delhi Cluster Office, organized "iTAGe: Talking Across Generations on the State of PVE in South Asia", an intergenerational dialogue that brought together six South Asian youth and four senior officials and policymakers to discuss peace and social cohesion in the region. The input collected from the event and the preceding survey and focus group discussions will be incorporated into a Youth-led Report on the State of PVE-E in South Asia as youth-centered actionable recommendations for policymakers.
